**Minutes of the Ordinary Meeting of the full Council
held on 11 November 2025 at 7.30pm in Tostock Village Hall
(Approved 13.01.26; minute 26.01.03 refers)**

25.11.01 Apologies for Absence

25.11.03 Minutes of the Last Parish Council Meeting
It was resolved that the minutes of the Ordinary Meeting of the Parish Council, held on 12 August, be signed as a true record.

25.11.04 County and District Councillors' Reports
04.1 County Councillor: Cllr Mellen presented his report further to which he noted that he still had funding available which the Council suggested might be put towards the Village Hall project.
04.2 District Councillors: Cllr Bradbury had sent apologies. Cllr Richardson presented his report, provided updates on several matters and agreed to pursue the cleaning of solar panels at The Croft.

25.11.05 Public Comment and Questions
Matters raised included the cutting back of vegetation encroaching on to Norton Road on the opposite side of Pamment Close, potholes on the gravel road at The Leys and the possible redevelopment of Woolpit Health Centre, all of which would be actioned as appropriate.

25.11.06 Correspondence
Cllr Storey reported on items both sent to and received by the Council. She noted the following in particular:

- ◆ That further to correspondence received concerning work to a driveway at a cottage on The Green, she had spoken with the relevant householder and agreed the way forward which required no further Council involvement.
- ◆ A finance query raised regarding the Council and grass cutting at the Church had been deferred pending the latter receiving further advice.
- ◆ An invitation from the organiser of the Woolpit Emergency Plan for the Parish Council to engage with the group responsible to produce a joint document was declined given that the villages were substantially different.

11.1 New Applications:

DC/25/04546 The Old Post Office, The Green - works to trees in a Conservation Area - oak T1 minor maintenance pruning to the lower branches of the oak tree. The proposed works involve selective lopping and reduction of these lower branches by up to approximately 2/3 metres. GRANTED.

DC/25/03895 Snapdragon, The Green - replacement roof to create loft extension; replacement of existing glazing; erection of single storey side and rear extensions (following demolition of existing garage). The Council had NO OBJECTION.
